Essex & Suffolk Water has launched a new interactive portal to make it even easier for you to report leaks on the street as soon as you see them. The portal, which can be accessed via laptop, mobile and tablet, is part of the company's quest to reduce the amount of water that is lost to leaks across its network. The portal, which can be accessed here, offers a simple map of the Essex & Suffolk Water supply area, allowing you to check if a leak has already been reported, and the status of the repair. If the leak is not already on the portal, it can be reported in a matter of minutes. You can even upload photos to help technicians locate the leak and determine how serious it is. Once a leak is reported via the portal, the information will be passed on to an advisor who will arrange for the leak to be investigated further. Updates on the progress of repairs will be provided on the portal, so customers can keep track of leaks they have reported. Figures released last month showed that Essex & Suffolk Water has reduced leakage to industry-leading levels. The company has cut leakage from 66.26 megalitres per day in 2017/18 to 64.17 megalitres in 2018/19, a reduction equivalent to more than 240 Olympic swimming pools per year. The leakage portal is one of a number of innovative techniques that Essex & Suffolk Water is utilising in their quest to reduce leakage. This includes space satellites detecting leaks from outer space - using the same technology that helps search for water on other planets to find leaks here on earth. Other techniques trialled by the company include the use of drone technology and sniffer dogs, which have been trained by ex-military dog trainers to sniff out the tiniest traces of chlorine used to disinfect water supplies. Help your local area by reporting leaks for engineers to take action and resolve (Image: Northumbrian Water) Eliane Algaard, Essex & Suffolk Water's water director, said: "We have set ourselves a target of reducing leakage from our water network by 17.5 per cent by 2025. "The latest figures show we have already made significant strides towards achieving this, by looking at any and all possible methods - no matter how out of this world they may be - and putting more resources into hunting down and repairing leaks. This has put us into an industry-leading position, having started at a very challenging position in 2017/18. "The support of our customers through the leakage portal, letting us know when they spot a leak, has also been brilliant, adding thousands of pairs of eyes to the work we do to find leaks, so we can fix them. "However positive the latest figures are, we will continue to use existing and new ways of finding and sorting leaks, to continue to drive down the leakage of this very valuable resource." The leakage portal also includes handy information on what to do if you discover a leak in your home. Whilst the water company is responsible for maintaining and fixing pipes on the road and pavement, it is the homeowner's responsibility for the pipework inside the home and any pipes underneath your garden or driveway. If you do need any plumbing work carried out on your home then Essex & Suffolk Water recommends using Watersafe - an independent body that helps customers in the UK find qualified, local contractors.
